#### **Course Description**

This course explores anthropological debates and themes of importance to the various sub-disciplines of Anthropology. The goal is to show how varying analytical perspectives on these broad themes produce divergent views of past and present human cultures.

# **Course Objectives**

By the end of the course students should be able to:

- Appreciate how the sub-fields of anthropology engage with a number of important themes.
- Develop the skills to critically evaluate ideas put forward in each of the sub-disciplines.
- Develop critical reading skills.
- Write a series of short critical reflection papers.

# **Class Format**

Lectures are delivered asynchronously and are posted by Tuesdays of each week. Synchronous Zoom sessions are held on Wednesdays on the dates posted below.

These sessions are mandatory to attend and you must come to class having done the required readings for that seminar theme.
