Course Description

Metabolic bone diseases are linked to a wide range of socio-cultural factors and this course explores the way in which information on the current occurrence of these conditions contributes to understanding factors operating in past societies. Information used in the course is derived from both clinical sources on contemporary health problems and paleopathology. The course allows students to focus on issues linked to metabolic bone disease in either past or contemporary groups.

Course Objectives

By the end of the course students should be able to:

- Have a solid knowledge of the biological mechanisms that underlie the metabolic diseases covered in the course and socio-cultural factors contributing to disease development.
- Be aware of current ideas in both biomedical/clinical and bioarchaeology/paleopathology research on the conditions.
- Be able to work both independently and as part of a team to introduce and lead discussion on topics.
- Develop an independent research project and present the results as a paper written in the style of a journal article.

Required Materials and Texts

- Brickley, M. Ives, R. & Mays, S. (2020). *The Bioarchaeology of Metabolic Bone Disease*, Second Edition. Academic Press: San Diego.

Class Format

The course is organized as a 2 hour and 40 minute seminar with no formal lectures by the course facilitator. The key text will be the *Bioarchaeology of Metabolic Bone Disease* by Brickley et al. 2020. In weeks in which a condition is discussed read the allocated paper and find an additional paper that can be used to contribute to discussion (a schedule will be distributed at the start of term. Papers should be uploaded to an agreed cloud folder by noon EST on the day before the class. Each class will start with a twenty minute introduction by allocated member(s) of the course to open discussion. Student letter allocations will be drawn randomly in the first class.

Course Evaluation – Overview

1. Presentations/leading discussion – 15% (split 20:20:60 between individual and group presentations to class (dates TBC). Presenting provisional research findings Dec 8th)
2. In-class participation – 20% (ongoing throughout course)
3. Research proposal – 15% due on Oct. 27th by 9am EST

4. Research paper – 50% likely to be due by 9am EST Dec 16th 2020 (TBC)

Course Evaluation – Details

Presentations and Leading in-class discussion (15%)

Each student will lead two discussions throughout the course. The first individually (3%) and the second as part of a team (3%). Students will be assigned their discussion weeks in the first class. Presentation of provisional research findings (8th December. 9%). You will need to prepare a 15 minute PowerPoint (or similar) presentation. This will cover your research questions, analysis, and interpretations as you have prepared them for your final paper.

In-class participation (20%), Ongoing throughout course

Students are expected to come prepared to class ready to actively participate in group discussions.

Research proposal (15%), due October 27th by 9am EST

This should set out the basic aims of the research topic and the research questions to be explored. Bullet points can be used to set out information. Word limit 1500 words + a bibliography of items cited.

Research paper (50%), likely to be due by 9am EST December 16th 2020 (TBC)

Choice of final paper topics is open; With COVID-19 restrictions students should plan for a project based on online material (published [available] papers, books or data sets/digital collections). Students can select a project related to their own research interests as long as they fall broadly within the scope of the course. Word limit of 6000 words, information included in a Table or Appendix and the list of literature cited do not count towards the word limit. Figures may be used.
