Course Description

The course will focus on the wide range of responses that healthcare providers and others have had to the issue of mental illness. Exploring interventions from sorcery and lobotomies to psychoanalysis and psychiatric medications, students will be introduced to the key issues and debates within the world of mental healthcare. Central questions include: how can we explain the diversity of treatment options within this world of mental illness? What ideas and ideologies guide the sorts of treatments that we have developed? Why, despite the availability of so many treatments, have rates of mental disability continued to rise in recent years? Students will consider these questions by engaging in a variety of asynchronous learning activities, including assigned readings and videos, online discussions, and short podcasts. Rather than being structured around weekly lectures, students are expected to do the majority of their learning via weekly self-directed modules.

Course Objectives

After the course, students should have a basic understanding of the many forms of treatment that have been used in mental health settings, both historical and contemporary. They should be able to discuss these forms of mental healthcare critically, considering the basic ideological and scientific assumptions built into these forms of treatment. Students should thus understand the ways in which mental health interventions relate to broader debates and discussions within the world of mental health and illness.

Required Materials and Texts

• All required readings, videos, and podcasts are available on Avenue to Learn.

Class Format

This course is offered largely asynchronously. Each week, a new module will appear that will include: 1) a short audio-video discussion led by the instructor, 2) a set of slides to guide your studying, 3) a set of weekly readings, and 4) a series of discussion questions.

Course Evaluation – Details

Class Policies Quiz (3%)

Students must complete a short multiple choice quiz about class policies on Avenue. The quiz is based on the syllabus and what is discussed in the introductory lecture.

Writing Tips Quiz (2%)

This short online quiz can be completed on Avenue to Learn. Students are required to read a description of common writing problems and then complete the subsequent quiz.

Essay (35%), due June 1st (or June 5th)

The essay (5-6 pages in length, double-spaced, Times New Roman 12pt font – please don't mess with the margins) requires students to select and answer a question on topics posted to Avenue. The essay is due on Avenue to Learn at 11:59 (on either June 1st or June 5th – see below). Students must use a minimum of SIX peer reviewed sources. Papers should be cited in full using APA referencing style. All papers should include a title page with the question clearly stated, as well as a bibliography.

Optional Essay Extension

The essay is due June 1st, but students may opt for a short essay extension until June 5th. It is not necessary to request this extension, as it will be automatically granted. If you opt for this extension, however, you will not receive any comments or feedback on your paper. Your grade will be posted on Avenue, but you will not receive the essay back. Neither the TAs nor the professor will discuss your paper or your grade in any fashion – no exceptions.

Weekly Discussions (5 x 6% each)

Each Wednesday between May 13th – June 10th, students will be required to make a post to a discussion forum on Avenue by 11:59pm. Questions will be assigned by the instructor / TA and will draw upon the course material. Students will be graded according to both completion and quality. Although the discussion will be slightly less formal than some academic papers (for instance, first person is acceptable), students are expected to post in a clear, formal, and scholarly manner.

Take Home Exam (30%)

The final exam is a cumulative, take home exam covering all course material. It will consist of a broad, open-ended long answer question. The primary focus will be on demonstrating a strong and in depth understanding of the course material rather than simply memorizing key terms. The final exam will require students to demonstrate their critical thinking skills and the ability to tie together disparate course components. Although students will have a four day window to complete the exam, it is designed to only require approximately 3 hours. The exam question and answer space will appear on Avenue to Learn, and the final exam will have a 750 word limit.
