Given my experience with teaching ECON 2HH3 (Winter 2020) and ECON 2ZO3 (Spring 2020 and Spring 2021) at McMaster University and several years of experience in a previous university instructor position, I believe it would be great to continue instructing at McMaster to foster an environment for high student achievement and strongly believe I can perform all duties for ECON 2HH3 superbly in the Winter term.

At McMaster, I enjoyed the opportunity of instructing ECON 2HH3 (Intermediate Macroeconomics II) and ECON 2ZO3 (Intermediate Microeconomics I). During my lectures, I engaged students using class discussions and framed concepts using relatable examples to enhance student understanding, and I greatly appreciated the contributions students brought to my lectures with their intelligent questions and participation. Also, I implemented weekly suggested problems and Avenue quizzes, which I utilized to incentivize students to review the course material on a regular basis. Additionally, I used Avenue's statistical tools for quizzes/midterms/finals to assess student understanding of course topics and adapt the course delivery to ensure student success (both theoretical and practical learning). During the COVID-19 pandemic, I rapidly adapted to online teaching where both synchronous and asynchronous tools were used to achieve the courses' learning outcomes.

In addition to my Bachelors degree in Math, I hold a Masters degree in Economics during which I served as a graduate assistant for 2 years. In my latter role, I was responsible for leading the Econ Lab Learning Centre, where I provided supplemental instruction to support students' learning success. Upon completing my Masters studies, I worked at the United Nations – ESCWA where I researched socioeconomic data for countries in a state of crisis/conflict, and performed statistical analyses in collaboration with colleagues from diverse countries.

After my work at ESCWA, I began my PhD studies in Economics and completed all necessary courses with distinction (ABD); the courses included Advanced Macroeconomic Theory, Advanced Microeconomic Theory, Econometrics, and Economics of Money and Banking among several others. Concurrently with my PhD studies, I held a university instructor position at BAU where I taught 3 courses per term in English and performed all related instructor duties. In addition to teaching a variety of economics and math courses, I served as the Course Coordinator for 2 courses across 3 BAU campuses, where I frequently communicated with professors and other university staff for course management purposes. I successfully demonstrated my communication, time management, and organizational skills.

During the 2017-2018 academic year, I had the privilege of delivering private supplemental instruction to a grade 9 student with ADD. Recognizing the student's needs, I utilized alternative delivery techniques that allowed the student to not only achieve a 25% increase in overall average, but also become capable of writing tests without assistance, demonstrating my ability to implement AODA and UDL principles. I understand that students learn in a variety of ways, and that a flexible and student-centered approach to supporting our students is critical to their success. I also believe that in a multi-cultural learning environment like McMaster University, it is vital for Professors to be able to understand and be sensitive to the cultural differences our students bring to the classroom and to one-to-one interactions. Given my prior experience, I believe that I bring a unique perspective and understanding and I would consider this to be one of my strengths in this role at McMaster.
