a. Projects currently in progress

My current research agenda comprises four projects, with each expected to appear as a book. One of these is with Brill publishers, two are with Oxford University Press, and one is with Yale University Press. Below, I describe briefly each projects:

- I am currently in the last stages of finishing a major research project sponsored by a SSHRC-SRG and the Alexander von Humboldt Foundation, which will serve as an advanced introduction to a largely unexplored group of the Dead Sea Scrolls: those written in Aramaic (as opposed to Hebrew or Greek). The results will be published by Brill in the Studies in the Texts of the Desert of Judah (STDJ) series. I expect to submit the finished manuscript by the end of May, 2021.
- I have been asked to write a monograph on one of the Dead Sea Scrolls (the Genesis Apocryphon) for the Oxford Commentary on the Dead Sea Scrolls

- series (http://www.ocdss.div.ed.ac.uk/#oxford-commentary-on-the-dead-seascrolls). I began working on this project in 2019.
- I have also been asked to write a volume on the ancient Jewish book of Judith in the new Oxford University Press series, The Apocrypha in the History of Interpretation (AHI). I will start on this once the above commentary is complete.
- I was recently asked to write a commentary on the Book of Tobit for the
 Anchor Bible Commentary series with Yale University Press. This is one of
 the top English-language commentary series on the Bible. I solicited coauthorship with professor Gary Anderson at the University of Notre Dame,
 and he has agreed to join me. We will begin working on the project in 2021.
- I also have several articles one which I am working at present, solicited by editors for various handbooks, encyclopedias, and edited volumes.
