leadership in delivery of educational programs

I served as Graduate Director of the Globalization MA program in 2011-12, 2012-13, 2013-14, and 2017-18. In addition to the normal administrative duties, I organized several reading groups, academic talks, MRP workshops, community engaged research seminars, and the annual MRP Colloquium. In 2018, I introduced two \$500 student prizes for the best MRPs produced by graduate students in the program each year.

I have served as the Convenor of the MA International Relations Colloquium in 2014-15, 2015-16, and 2018-19. The Colloquium features presentations by faculty members, former graduates who have gone on to PhDs, University librarians, members of the McMaster Research Ethics Boards, and representatives from international agencies and the provincial government. I also organize several seminars on applying for grant funding, academic publishing, and MRP preparation.

course/curriculum development

Together with Dr. Don Goellnicht and Dr. Rachel Zhou, I developed a new graduate course (Globalization 709: Designing Global Research: Approaches, Methods and Techniques) on research methods for studying globalization. Since 2017, this is a required course for the Globalization MA program.

I delivered a series of non-credit graduate seminars in the summer of 2011 on Citizenship theory and practice. The lessons I learned from these seminars were integrated into my graduate course Political Science 776: Advanced Issues in Critical Security Studies. Between 2012-16, this course was taught with the theme of "Citizenship & Security."

While I regularly update and redevelop the courses I teach, I first designed and taught the following courses:
