Course Description

This course runs over the Fall and Winter terms in the students graduating year. Three units at Level IV are awarded upon successful completion of the course. Students enrolled in a departmental B.A. Combined Hons. B.A., or Hons. B.A. program complete a variety of tasks that enhance their appreciation of the academic study of religion. The course is administered through Avenue by students' departmental faculty mentors.

Course Objectives

By the end of the course students should be able to:

- Engage critically with academic presentations involving and invoking "religion;"
- Reflect on, revise and adapt their own approaches to the study of religion;
- Cultivate an on-going engagement with all things religious in society and culture.

Class Format

In term one this course will be held exclusively online. Students will work independently but regular Zoom meetings will occur at mutually convenient times.

Course Evaluation – Details

Book Review (20%)

A careful and thoughtful evaluation of a "classic" in the academic study of religion.

Revision Assignment (20%)

Each student will take a written assignment submitted to a course in Levels I or II and revise it based on their current understanding of the academic study of religion.

Attendance and Discussion (20%)

Each term we will attend two academic presentations (virtual or live) and discuss each as a group together.

Observation and Reflection Assignment (20%)

Each student will take one hour to be present at any public location in order to observe and reflect on the presence (or absence) of religious symbols, behaviours, images, etc.

Participation and Engagement (20%)

At our regular meetings we will engage with each other's work underway at that point in the course. Students are responsible for collegial and helpful feedback on work in progress.

Course Schedule

Meetings will be arranged at regular and mutually convenient times throughout the academic year.
