## **Course Description**

An introduction to the writings of the Hebrew Bible/Old Testament in their historical setting, to their role as scripture in Jewish and Christian tradition, and to various methodologies used in their modern academic study. (Formerly RELIGST 2HB3)

# **Course Objectives**

By the end of this course students will have:

- Become familiar with the contents of the Hebrew Bible/ Old Testament;
- Encountered a range of approaches to the academic study of the Bible;
- Understand how the HB/OT has functioned as scripture in various historical contexts.

#### **Required Materials and Texts**

English Translation of the Jewish Bible (Tanakh) or the Christian Old Testament. An ad-free online version is available from the University of Michigan.

## **Class Format**

This course will be conducted online and asynchronously. New materials will be posted each week and it is your responsibility to keep up with the readings, assignments and other learning tasks. Some opportunities for online discussion will occur throughout the term.
