### **Course Description**

In this class, we will explore both classic and contemporary social psychological theories. Over the course of the term, we will review and critically evaluate the following general theoretical perspectives: Symbolic Interactionism, the Cognitive Perspective, Social Exchange Theories, Personality and Social Structure, and the Justice Framework. For each section, students will become familiar with the history, the development, and the core ideas of each perspective. From there, we will examine how social psychological theory has contributed to our understanding of social reality, the self and identity, prejudice and discrimination, as well as crime and deviance.

### **Course Objectives**

By the end of the course, students will:

- Possess knowledge and critical understanding of the key theoretical approaches, current advances, and key concepts in social psychology
- Understand and appreciate the strengths and limitations of each theoretical approach
- Be able to apply concepts and ideas learned in this course outside of the classroom
- Have enhanced their critical thinking, writing, and organizational skills through course assignments
- Have enhanced their communication skills through class discussions.

### **Required Materials and Texts**

### **Class Format**

Lectures will be held in-person, unless otherwise specified. Lectures will take place on Thursdays from 11:30-1:20 in HSC 1A6. Tutorials will also be in-person. You must attend the tutorial that you have been assigned through Mosaic.

While attendance is not mandatory, it is strongly encouraged. With that being said, please do not come to lecture/tutorial if you feel unwell. This is especially the case if you are experiencing COVID symptoms and/or have tested positive. Contingencies will be in place if you are unable to attend. This will be addressed during the first lecture

The format of this class may change due to the ever-changing nature of the pandemic. If the university closes, the lectures will be moved to a virtual format until it is safe to return to campus.

### **Quizzes (5% Each = 10%), Due: Sept. 29 and Nov. 24, 2022**

Throughout the term, you will complete TWO quizzes that will be based on both lecture and reading material. Each quiz will consist of 10 multiple choice/true or false questions. They are open-book assessments and will be administered through Avenue to Learn. You will have 15 minutes to complete the test, which will be available from 9am-9pm on the day they are due

### **Midterm Exam (25%), Due: Oct. 27, 2022**

The exam will be based on both the lectures and the readings. It will consist of multiple choice, true or false, and short answer questions. Unless otherwise specified, the exam will be held in-person during class time

### **Final Assignment (30%), Due: Nov. 17, 2022**

For this assignment, you are asked to critically evaluate a social psychological theory of your choice. A more detailed breakdown of the assignment will be provided on Avenue

### **Final Exam (25%), Due: TBD**

The exam will be based on both the lectures and the readings. It will consist of multiple choice, true or false, and short answer questions. Please note that the exam is **not cumulative**. Unless otherwise specified, the exam will be in-person and will be scheduled by the Office of the Registrar

### **Late Assignments**

The due dates for assignments are fixed and non-negotiable unless you are registered with SAS or submit a McMaster Student Absence Form (<http://www.mcmaster.ca/msaf>). The MSAF is a self-reporting tool for Undergraduate Students to report absences for medical or other reasons that last up to 3 days and provides the ability to request accommodation for any missed academic work worth less than 25% of your overall. ### **Review of Marks**

To request a review of a mark, write a ½ page memo describing in detail the nature of the perceived marking error and submit this memo to your Teaching Assistant. If, after this review of your mark, you continue to dispute the mark, you may submit an appeal to Dr. Speakman. Dr. Speakman will not review any marks not already reviewed by the respective Teaching Assistant.
