# UNDERSTANDING LIVED EXPERIENCES: STIGMATIZED IDENTITIES

#### **Course Description**

Using social psychological theoretical perspectives, this course will provide insight into understanding the lived experiences of those living with **Stigmatized Identities**. We will begin by examining how social psychologists study lived experience, both theoretically and methodologically. This will be followed by a discussion of the theory of stigma as it was conceptualized by Erving Goffman as well as more contemporary conceptualizations. The second part of this course focuses on case studies that examine these lived experiences. Here, we will not only be discussing the substantive topics under review, but also delving into issues such as multiple stigmatized identities, medicalization, managing stigma, and the like. This course is designed to get students critically thinking about how stigmatized identities are experienced and the impact that these identities can have on the individual, the group, and society.

## **Course Objectives**

By the end of the course students should be able to:

- Understand the dominant theoretical and methodological perspectives that are
  utilized to study lived experiences more generally, and those living with deviant
  and stigmatized identities more specifically, as well as appreciate the strengths
  and limitations of these approaches
- Gain a critical understanding of the impact that the individual and society has on people living with stigmatized identities
- Be able to apply concepts learned to current situations and events in the community and around the world.
- Enhance students' critical thinking, writing, and organizational skills through course assignments, as well as enhance students' communication skills through on-line class discussions.

## **Required Materials and Texts**

All readings will be available through Avenue to Learn.

#### **Class Format**

This will be an on-line asynchronous class format primarily run through Avenue to Learn. Recorded lectures will be posted weekly, along with Power Point Slides and any other material associated with weekly lecture content. That being said, for students who wish to join the lecture "live," I will also be providing the option of attending the recording of the lecture. The date and time are forthcoming.

## **Course Evaluation – Details**

#### Critical Reflection Assignment (20%) May 21, 2021

The first assignment will require you to critically engage with the course material covered so far. Here, you will reflect on the readings and lecture material, and connect the material to the 'real-world.' You may also choose to ground the material in your own lived experiences of stigma and use what you have learned in this class to analyze these experiences. A more detailed breakdown of the assignment will be provided on Avenue.

#### Mid-Term Exam (25%) May 19, 2021

The exam will be a take-home format with both short and long answer style questions. The exam will be available from 9am-9pm on May 19 and will be submitted through Avenue to learn

#### Research Proposal (30%) June 9, 2021

For this proposal, you will get the opportunity to explore the lived experiences of a stigmatized group of your choice and address some of the potential theoretical and methodological issues that your proposed research may run into. This assignment may be done individually or in pairs. A more detailed breakdown of the assignment will be provided on Avenue.

## Final Exam (25%) June 16, 2021

The exam will be a take-home format with both short and long answer style questions. The exam will be available from 9am-9pm on June 16 and will be submitted through Avenue to learn
